Surety hereby waives and relinquishes its right to require, by notice in writing, the Obligee to bring an action on the contract against a Principal when such right of action has accrued. Failure on the part of Obligee to bring such action does not discharge Surety from liability on the instant agreement. Surety further waives any and all additional right not specifically mentioned herein which might accrue as a result of Obligee's failure to pursue Principal.

For the purposes of this agreement, Obligee has the sole and exclusive discretion to determine the date on which a Principal is deemed to be in default on its payment obligation.

The Surety may cancel this bond for any reason, including default on the part of the Principal, upon thirty- (30) days written notice to the CITY OF TUCSON. It is understood that in the event of such cancellation, Surety remains responsible for and shall pay or cause to be paid to the CITY OF TUCSON any or all charges for utility services supplied at the above referred to place of business prior to the effective date of cancellation of this bond.
